BIDDERS SHALL TAKE NOTE OF THE FOLLOWING CONDITIONS:

- 1. Bidders must submit together with their bids a copy of company registration document (CK).**
- 2. Bidder must be registered in the national treasury Central supplier database (CSD)**
- 3. Failure to submit SARS Tax Original Certificate or printed copy of Tax Compliance Status pin, certified copies of ID's of directors may result in a tender deemed non-responsive.**
- 4. Failure to submit certified BBBEE CERTIFICATE will result to a bidder losing points allocated for BBBEE.**
- 5. Failure to submit comprehensive JV agreement (where applicable) will result in a tender deemed non responsive.**
- 6. Failure to complete the tender forms e.g. Form of Offer, declaration of interest, will result in a tender deemed non-responsive.**
